This endorsement modifies insurance provided under the following:

DISASTER MORTGAGE PROTECTION

In consideration of the premium charged, it is hereby understood and agreed that this policy is extended to provide you, the insured, a \$ _____ monthly indemnity benefit when an occurrence resulting in property damage on your insured location renders your insured location uninhabitable. Coverage under this endorsement will apply only when Insured meets the following conditions:

- A. Homeowner's coverage insured the dwelling at the time of loss.
- B. The dwelling was not vacant at the time of loss.
- C. Emergency Cash (loss of coverage) is limited to a maximum of \$ _____ per
 Calendar year or per membership year.

In consideration of the premium charged, it is also hereby understood and agreed that this policy is extended to provide you, the insured, a \$50 reimbursement for the services of a locksmith when you are accidentally locked out of your insured location. The lockout benefit is limited to two (2) claims per year and meets the following conditions:

- A. You submit a copy of the locksmith's bill
- B. You provide proof that you paid the bill.
- C. The lockout benefit is limited to two (2) claims per calendar year or per membership year.

All other conditions of this Policy apply.
